Superintendents Report

- Writ of Mandamus update
 - Review of VACLC Writ of Mandamus history since 2018, currently at 2nd District Appellate Court. Second lawsuit filed for un-paid attorney fees was won. Still awaiting first suit for increase in services for Veterans in Lake County. Actively working on appeal, plans in place for growth of services for Veterans in Lake County once awarded. Effective date of lawsuit is 11/19/2018, once awarded retroactive pay for budget increases will be due.
- <u>IACVAC</u>
 - Annual meeting held in January. Superintendent Tangen elected as President and COS/SVSO Murray elected as 1st District Vice President.

- <u>Legislative update</u>:
 - House Bill 2378 sponsored by Rep. Joyce mason for Surviving Spouses and Permanently disabled children of both deceased parents for property tax exemption statuses, recommend
- <u>NACVSO Update</u>
 - Washington DC February for Legislative conference; Superintendent Tangen and COS/SVSO Murray in attendance. Honoring PACT Act supported in support of 23 presumptive conditions for GWOT/OIF/OEF Veterans. Also adds presumptions to Vietnam Veterans served in Thailand, no matter where on base, as opposed to only perimeter. Additional benefits for Ionizing Radiation Veterans to include additional presumptive conditions and locations.
 - CVSO Act supported to add supplementation for CVSOs in addition to County funds. This act was merged with Honoring PACT Act which passed the house and is currently waiting on Senate vote.
 - National Convention in San Antonio June 5-11. Office will only be manned by Admin Assistant.
- <u>IACO</u>
 - Annual legislative meeting May in Springfield for Superintendent, Assistant Superintendent, and COS/SVSO.
- Mental Health First Aid Training
 - Massive increase in MH issues and suicide within our County/State/National Veterans of all eras. MHFA Training was scheduled Feb 25, 2022 at Antioch Post, only 4 signed up out of 25, training had to be cancelled. Need support of Veteran Service Organizations to sign up and get help and assistance to increase support of MH for Veterans of the County. VACLC will be providing training, food. Will work to re-schedule, once scheduled a minimum of 1 representative from each Veteran Organization to sign up. Can be scheduled 1, 8hr day or 2, 4hr days.
- <u>Staff Update</u>
 - o Introduction Allan Lacson, new VSO. Passed NACVSO Accreditation last Friday.

 - Added by Superintendent: importance of Witness slips, they tell the State Representatives and Senators how important a Bill is to the public. The number of proponents vs. opponents becomes key to supporting a Bill to be passed.
- Larry Klauser:
 - Jim Nelson now PGA Hope ambassador for IL. Includes training sessions at various area Golf courses with PGA Professionals. 2022 schedule is out, registration coming in the next few weeks. Jim is available to come out and share about the program. All levels of Golfers can participate.
- \$500 donation to VACLC NFP from AML Vernon Hills Post 1247 Jim Schultz
 - NFP funds are used to supplement aid to Veteran in need when unable to use County Public Aid funds.
 - Examples of 2 recent assistance with NFP funds:
 - Female Veteran in abusive relationship to get out of situation with oneway U-Haul to move herself and kids out and to Michigan with her family.
 - 80yo Retired MSGT living at home independently, had shared well on property which had a circuit breaker attached to neighbor's house that caught fire, leading to no water for months. Some county funds used to install new well for \$15,000. \$1,500 for additional stump removals and construction assistance used from NFP.
- President Kontz:
 - Mundelein post will be distributing Poppies this Memorial Day weekend, slots still available to sign up.

- Had a Veteran in need for transportation from his home in Kenosha to Germantown, WI for compensation & pension eye exam. Appointment was arranged for Veteran through scheduling services. Barry drove 1hr from home to Kenosha, an additional 1hr to Germantown. Exam office was unoccupied, calls to services resisted giving provider information for 30 mins. By the time the eye doctor was contacted they could no longer see the Vet and referred him back to scheduling services/contractor.
 - Feedback from VACLC: certain C&P contractors do offer transportation. Please contact VAC to record complaints or poor service for C&P examiners to be reported to VA contracting services and reflected in the Veterans claim file.
