• FHCC offices update

- o Furniture, scanner, phones, and computers are in and working
- Plans initially to have one service officer there, gradually adding staff
- o Rotating staff have keys will attend initially one day per week (one administrative assistant and two VSOs, eventually we will be there five days a week
- o We will be meeting with sailors getting out of the service for BDD claims
- Opening date is pending, early 2024
- President Konz added when, No Veteran Dies alone that a notary needs to be there,
 Assistant Superintendent Murray stated, the VAC staff are notaries, and we can assist with notarizing documents

• Superintendent's DC Trips


- O Superintendent is the First Vice President of the National Association of County Veterans Service Officers and has insight on two pieces of legislation
 - GUARD Act, S740 at 118th Congress-Governing Unaccredited Representatives
 Defrauding VA Benefits. It was put together to prevent claim sharks from taking
 Veterans compensation away from them and can allow legal actions against them
 for criminal charges or take away their law licenses
 - PLUS Act of 2023-Preserving Lawful Utilization of Services for Veterans Act of 2023. This allows Veterans to retain their use of private sectors organization with no restrictions. They are not telling Veterans and their family members that many organizations do not charge for the same thing the private sector does
 - Our organizations have come together to stop the PLUS Act from being passed
 - We are fortunate that our Superintendent is an attorney
- o \$5.4 million budget passed unanimously
