# Approval of minutes of previous meeting- May 17, 2023

- Motion made by Delegate Schultz
- Seconded by Delegate Mockapetris
- Motion to approve previous minutes passed

# **Superintendents Report**

- Sherry Kruse resigned in July for personal reasons
- Resolution 23-007 to appoint John Murray as new Assistant Superintendent
  - Motion to approve made by Delegate Klauser
  - Seconded by Delegate Honeywell
  - Motion to approve Resolution 23-007 passed
- Land purchase and Special Use Permit (SUP) acquisition
  - Location is on south side of Grand Avenue in the lots previously used by Joe's Crab Shack and Outback Steakhouse
  - Our use is governmental, not commercial
    - SUP required
      - No tax revenue generated
      - No property taxes paid
      - Village of Gurnee does not believe this would be a hardship
        - o Gurnee has not levied a property tax in 23.5 years
    - County and Village of Gurnee has reviewed architect's plans and submitted paperwork and ready to proceed
    - Zoning Board meeting set for end of September
    - Final approval in front of the Village Board will be in October
      - Original land purchase would have been finalized Sept 15 but was delayed for the Village Board to meet and approve this SUP
      - New closing date will be Oct 25 or once SUP is secured
    - Question: Has the VAC reached out to the school district since they are the main stakeholder of property tax revenue?
      - No, we have not. The Village of Gurnee does not think this is an issue. The County is not involved. It is a Zoning Board issue

- IACVAC conference
  - State organization
    - Held in Peoria
  - o Andrew Tangen and John Murray will head down September 20, 2023
  - Shane McNerney, Summer Padaoan and Jonathan Kellogg attend starting September 17
    - Jonathan will be attending for the first time
    - Shane and Summer who are part of the Education Team will be holding trainings for other VSOs to learn from
- NACVSO Conference Update and Leadership Update
  - o Held in June in Madison, WI
  - Meetings were had with the Secretary of the VA, Undersecretary of Benefits,
     Undersecretary of Cemeteries, and several of their key staffers
  - Obtained a lot of really good information
    - Toxic Exposure Risk Activities Memos under the PACT Act
      - If a veteran had exposure to toxic substance risk activity during any part of their service time, the VA has to process the claim
        - Example: Heavy machinery operators or mechanics would be eligible under the Act even if they never went to Vietnam or Iraq based on exposure of fuel, grease, exhaust, etc. and things like Non-Hodgkin's Lymphoma would be a known presumptive
        - Please advise your Post and other veterans even if they didn't serve overseas, they may qualify for toxic exposure based on their MOS so please urge them to reach out for help with benefits and health care
        - Benefits and conditions previously denied may be reconsidered and approved so reach out to a qualified organization for help
  - John Murray was elected as the Judge Advocate to NACVSO
  - Andrew Tangen was elected First Vice President for NACVSO
- New office space is operational
  - o Tours given after meeting
  - Additional space allows room to grow and accommodate new staff
    - If asked why we are hiring additional staff, please advise Lake County is the <u>only</u> county in Illinois to increase their veteran population
      - Increase of 13,000-14,000 persons in a two-year time period bringing the total number from 31,000 to 45,000 individuals
    - Lake County is also the <u>only</u> county in the state where the majority of veterans are under the age of 60
    - Our organization will need to continue to grow to address the needs of those veterans and their families
- Veterans Day
  - o Please make staff speaking requests earlier rather than later
  - Veterans Day, Fourth of July and Memorial Day are our most common requested days for appearances
  - o Requests are evaluated first come, first serve
  - O John Murray and Jonathan Kellogg are already committed to Lindenhurst as they have leadership roles there

- Budget Update
  - o Budget was submitted well ahead of time
  - O Similar to last year at \$5.4 million dollars
    - Includes increased staff size, money allocated for land purchase and some towards the building itself
    - Currently in the capital raise phase which is gathering capital to build
- Offices at the Captain James A. Lovell Center
  - o In process for the last 14 months
  - o Two offices located in Building 135 right off the elevator
  - o Walls are painted, new furniture, new phones
  - o Ceiling collapsed before open to water damage from repair work done on floor above
  - o Open is delayed
- Update on Fort Sheridan Cemetery Land Purchase
  - o Land was originally donated to the Forest Preserve
  - Approximately five acres needed to be transferred under the Downstate Forest Preserve Land Act
  - o Act had to be amended in order to accommodate this transfer which happened
  - Approved amended Act then needed to be approved by the Forest Preserve which happened
  - o General Assembly then wrote a bill to approve amended Act which went through both houses and be signed by the Governor which has happened
  - o Currently back to the Forest Preserve to actually enact the transfer of deeds and land
  - No firm ETA but Andrew will reach out to the Forest Preserve for more concrete estimates keep the delegation informed
  - Coalition support has been critical to this process
  - o Fort Sheridan will be all cremated remains
    - Only in-ground exception will be remains of those Killed In Action that have been repatriated
      - Higher level veteran in-ground burial requests from a Medal of Honor recipient, a Two Star General, and a Four Star General are currently being denied by National Cemetery Administration
        - Other entities are looking into this policy for possible revision for these specific exceptions
    - In-ground allotments are 6'x6' allowing for 3,000 additional in-ground burials
    - Columbarium allotments are 4'x4'allowing for 80,000 additional columbarium burials
    - Question: If the veteran reserved an in-ground spot at Fort Sheridan before the policy was changed will that be honored? This is iffy. Fort Sheridan falls under the Abraham Lincoln Cemetery Director's control and last communications 24 months ago were that the no exceptions will be upheld: Cremains only unless Killed In Action
  - o VAC office can help with Pre-needs Burial Evaluation Requests
  - o Funeral Homes can help prep with forms that would be submitted upon death but not ahead of time
  - Other scam entities may be charging for preparing forms for burial or headstones or incur the family later charges by filling out forms incorrectly so please speak directly to the VAC for these matters
